

Privacy Statement

1. Collection and processing of data

We, the Suplie GmbH Stockumer Straße 8, corner Sim Ju, 59368 Werne a / d lip, take the protection of your personal data very seriously and abide strictly to the rules of data protection laws. Personal information will only be collected via this website to the extent where this is technically necessary, or for finalizing business contacts and thereby sending out information, promotions or offers of the Suplie GmbH.

Further personal data are

only collected if you provide this information voluntarily, e.g. as part of an inquiry, reservation (by phone and in writing) or make a registration. In no case will the data be sold or passed on to third parties for other reasons. Unless this data will need to be used for operational, tactical or strategic marketing activities of the company of Suplie GmbH or some sort of other supporting internet platform.

The following explanation will have an overview of how we guarantee this protection and what type of data is collected and for what purposes.

2. Use and disclosure of personal data.

The personal data given to us by yourself will be treated with the utmost confidentiality and will only be used to answer your inquiries, process your orders or for marketing purposes (for example newsletters), see above. Your personal data will only be transferred to third parties whenever this serves the purpose of the contract – this is often in particular required for transferring order data to suppliers or for administrative purposes - or when you have previously agreed with us to do such. Furthermore, we may transfer personal data for the purpose of marketing activities of the Suplie GmbH. At all times do you have the right to cancel your given consent, either written or via telephone.

3. Right of information

Due to the fact that your concerns are important to us, we desire to give you correct information at all times. We will inform you about the process of saved, personal data on written request.

4. Cookies.

This website uses so-called cookies in several places. They serve to make our offer more user-friendly, more effective and safe. Cookies are small text files that are stored on your computer by your browser. Most of the cookies we use are „session cookies“. They are deleted automatically after your visit. Cookies do not harm your computer with viruses.

5. Newsletter

If you would like to receive our Newsletter, we require your email address as well as your consent, which you can do by pressing the „Subscribe“ button. You can choose to unsubscribe from this newsletter in the same manner by simply pressing „Unsubscribe“. At all times do you have the right to withdraw your consent for the use of personal data and email address that is used to send out the newsletter.

6. Deletion and revocation

The deletion of stored personal data will commence, if you revoke your consent to storage (see point 2 and 5) if your saved data are no longer necessary to fulfil set goals by the company or if the storage of your data is not permitted for other legal reasons.
